Gary Valentine – School Com 608 – School Safety

Mr. Walderzak introduced Gary Valentine. Valentine is our truancy officer for the ISD. Mr. Valentine also works with school districts in our ISD on school safety. Valentine is a retired police officer. Valentine has came up with the first critical emergency response program for Michigan since the Columbine incident. Valentine makes a response plan with the local fire department and ambulance service for the school district. Valentine will come and do a lock down drill and evaluate response.

Hubbard states that he appreciates the work that Mr. Walderzak has done to get this program started along with our cardiac response.

Bullying

Walderzak stated that we had 5 incidents of bullying reported and dealt with this school year. The bullying stopped after they were reported and dealt with.

Homeless Report

Walderzak gave the board a report on the homeless situations in our area. Walderzak stated that Mrs. Gates is our first contact and fills out all of the paperwork.

Wellness Team Update

Walderzak stated that the identity of this group is to help students make healthy choices. The team is also looking at Neola Policies and Reproductive Health. They have promoted water and the importance of drinking water. Other projects have been sunscreen awareness, and walking more. The Wellness Team had a walk-to-school day. The team will host a color run for next year as a little fundraiser to help promote healthy choices.

NWEA Report- Weaver

Weaver have a presentation to the board on the growth from the NWEA scores. Their growth from fall to spring is amazing. Weaver stated that most students are growing 1 year to a year and a half in growth. Weaver talked about some of the interventions that the districts has done over the year and plans for next year. With the extra ELA teacher in the middle school the students will have two full hours of ELA. Weaver reported that our students and staff are working very hard and making huge growth.

Preschool Update

Weaver stated that right now in legislation the governor is changing the law that students have to be 4 by September 1st to attend preschool. Because this change next school year the district will only have 2 preschool classrooms.
