Virtual School--Dallas Bell

Mr. Bell, Dr. Sabastian and Mr. Mobley came to the board to talk about the achievements of the students from Vestaburg attending the virtual program. The test scores, graduation rate are all moving in the right direction. Mr. Mobley talked about working with the kids here at Vestaburg and also working with them at the Virtual program. Mobley feels that the students are more comfortable when they see a familiar face. Mobley talked about being able to offer a different opportunity for those students that need it. The virtual program has also offered summer school the last two years.

As of today they have had 17 students graduate from Vestaburg through the virtual program. Bell talked about the next step that the program is working toward. The Vestaburg Virtual Program will be offering a pre-nursing program next year. This will give Vestaburg a step up above other schools. The virtual program will be moving to our old central office building next year. The Michigan Virtual program will be renting the building for \$15,000.00. Hubbard talked about the partnership with the Michigan Virtual Program we can give the students an opportunity to also learn a skill along with graduating. With the board approval they will begin renovations in January. McNerney asked about who collects the FTE for those students.

Hubbard stated we will bring this to the board for approval of a 5 year agreement in November.

Priority Quarterly Update

Hubbard stated that the board can read their report. Hubbard stated we are doing very well with our curriculum and test scores.

NWEA Update

Weaver talked to the board about the NWEA initial testing. Weaver talked about the percentage of students showing growth and the goal for this year is 80%. Weaver talked about the District School Improvement with common intervention time, math intervention, math coach, ELA coach. Weaver talked about a strategy Lori Wolfe is working on with 9th graders. The program works with the NWEA scores and builds an online program specifically for what they are lacking.
